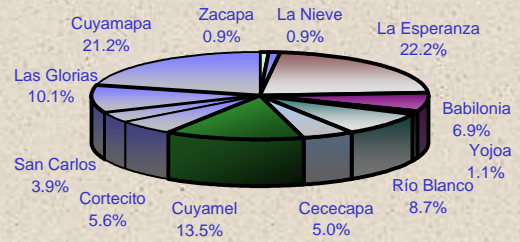

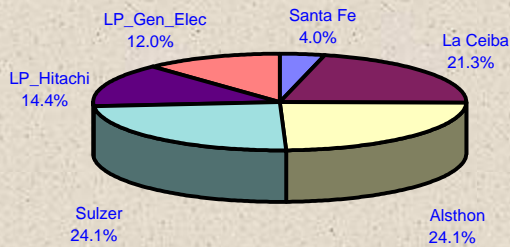

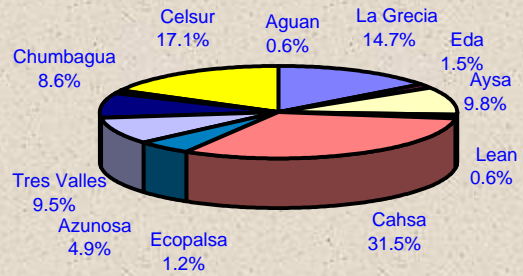
Plantas Hidroeléctricas Privadas



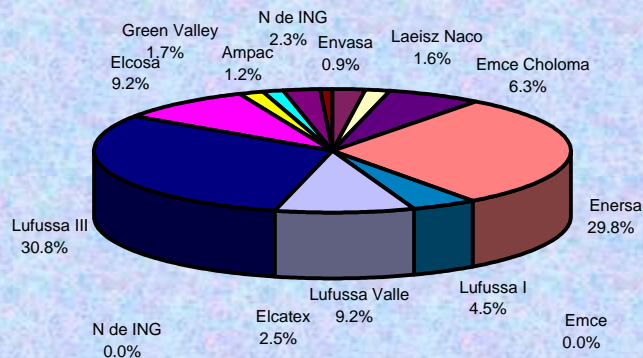
Plantas Térmicas Estatales



Plantas Biomasa



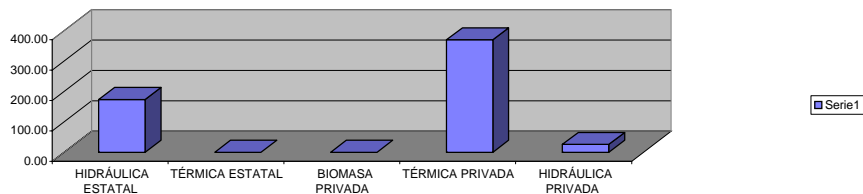

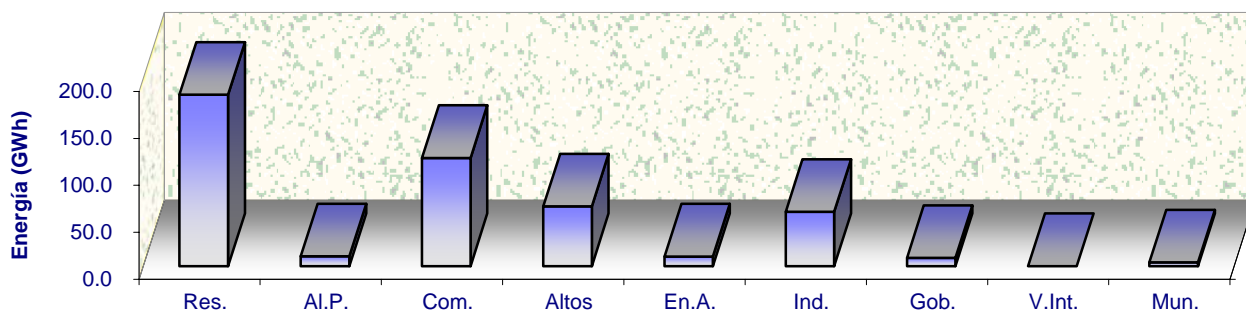

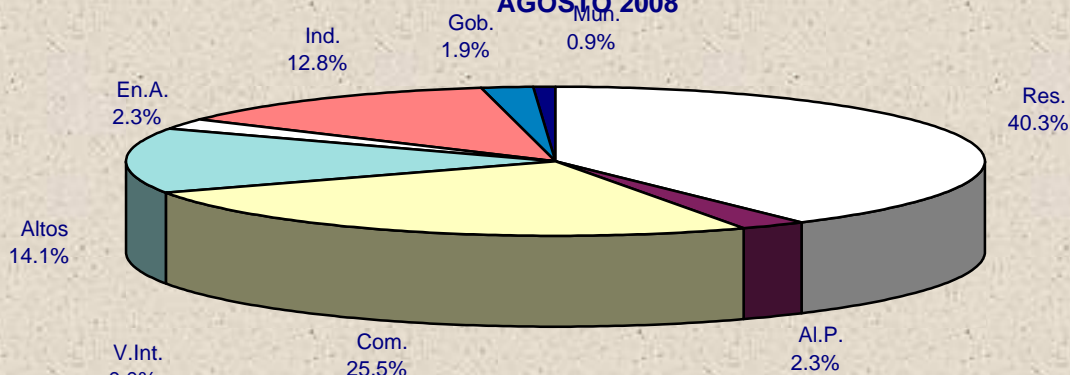

ENERGIA VENDIDA POR SECTORES DE CONSUMO AGOSTO 2008

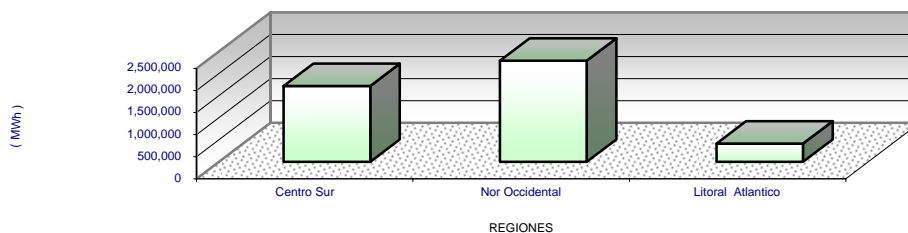

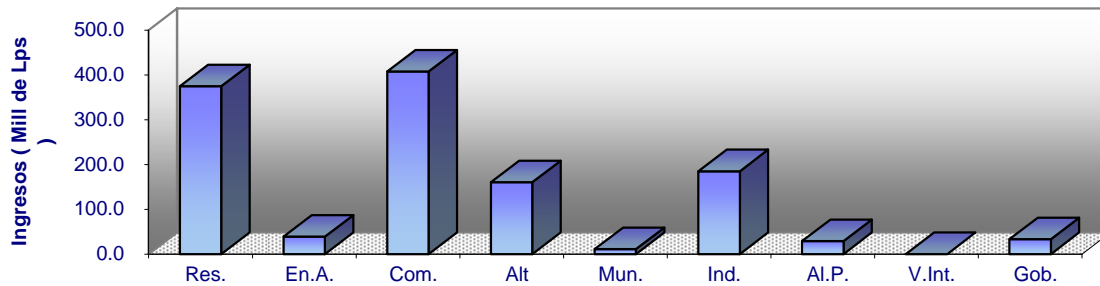

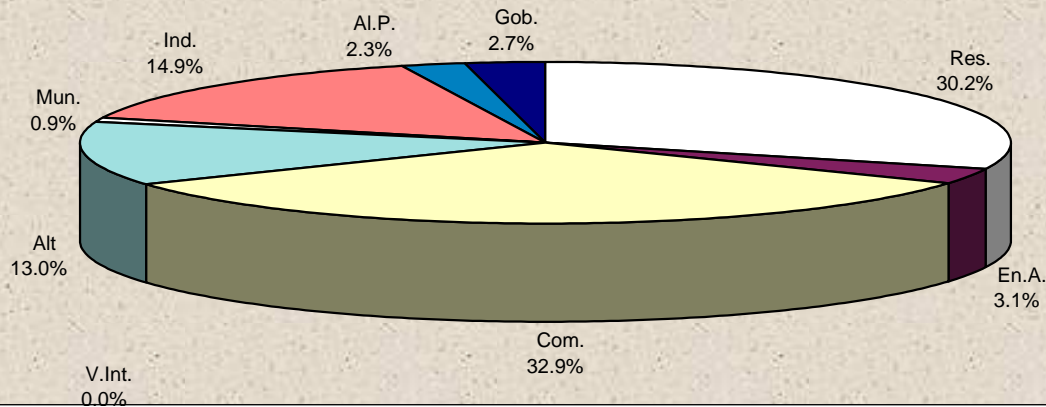

INGRESOS POR VENTAS DE ENERGIA AGOSTO 2008

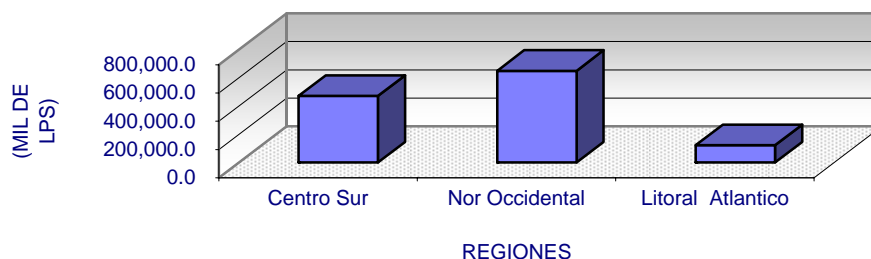
